"ALL that certain piece, percel or let of land, with all haprovements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the southern side of Linwood Avenue and being known and designated as Lot No. 43 of McSwain Gardens Subdivision, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book "GG", at Page 75 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Linwood Avenue, joint front corner of Lots Nos. 42 and 43 and running thence with the common line of said lots S. 10-00 E. 153 feet to an iron pin; thence with the rear line of Lot No. 43 S. 78-23 W. 100.05 feet to an iron pin; thence with the common line of Lots Nos. 43 and 44 N. 10-00 W. 155.8 feet to an iron pin on the southern side of Linwood Avenue; thence with the southern side of said Avenue N. 80-00 E. 100 feet to an iron pin, the point of beginning.
