"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, containing 16.94 acres, more or less, as shown on a plat of property of Leila N. Dunn and G. C. Nicoll, prepared by C. O. Riddle, R. L. S., August 12, 1953, and having according thereto the following courses and distances, to-wit:

BEGINNING at a pin in the center of a county road at the corner of Wagner property, and running thence along the center of said road S. 42-45 W. 1029 feet to an iron pin on the northern side of said road; thence S. 43-0 W. 469 feet to a pin on the southern side of a road; thence N. 14-54 W. 905 feet to a double pine; thence N. 67-45 E. 1234 feet to an iron pin; thence S. 24-15 E. 270.6 feet to the point of beginning.
