"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, near St. Mark Church (ME), being known and designated as the eastern one half of Lot No. 1, on Plat of property of the James H. Priestly Estate, said plat made by H.S. Brockman Surveyor, Oct. 23, 1947, and being the same lot of land conveyed to me by deed from Charlie and Annie Mae Hill dated , and recorded in the R.M.C.
