MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I. Robert L. Pinson, of Greenville County

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Sixteen Thousand, Five Hundred and No/100-----(\$16,500.00 Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of One Hundred Eleven and 41/100-----(\$ 111, 41

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings under any proceedings and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Yorkshire Drive (formerly known as Mabel Avenue), being known and designated as Lot 82 on Plat No. 2 of Property of James M. Edwards made by Dalton & Neves, Engineers, August 1955, and recorded in the R. M. C. Office for Greenville County in Plat Book II at Page 120 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeastern side of Yorkshire Drive at the joint front corner of Lots 82 and 83 and running thence with the line of Lot 83, N. 33-38 E. 200 feet to an iron pin; thence S. 56-22 E. 100 feet to an iron pin; thence S. 33-38 W. 200 feet to an iron pin on the northeastern side of Yorkshire Drive; thence along Yorkshire Drive, N. 56-22 W. 100 feet to the beginning corner; being the same conveyed to me by Alene R. Hastings by deed dated October 31 , 1967 to be recorded herewith. "
