...(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, side of Henderson Road in the City of Greenville, and known and designated as Lot No. 70 of a sub-division known as Gower Estates, Section F, plat of which is recorded in the R.
