NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All the exertain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northeastern side of Rock Hill Road, near the City of Greenville, being shown as Lots 20 and 21 on a plat of Dreher Colony Subdivision dated January 31, 1964, prepared by R. K. Campbell and H. C. Clarkson recorded in Plat Book FFF at page 41 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Rock Hill Road at the joint front corner of Lots 21 and 22 and running thence along the line of Lot 22, N. 31-51 E. 150 feet to an iron pin; thence N. 59-50 W. 160 feet to an iron pin; thence with Lot 19, S. 30-46 W. 150 feet, more or less, to an iron pin on the northeastern side of Rock Hill Road; thence along Rock Hill Road, S. 63-10 E. 63 feet to an iron pin; thence still along Rock Hill Road, S. 58-20 E. 102 feet to the point of beginning.

This being the same property conveyed to the Mortgagors herein by deed recorded in Deed Book 820 at page 539.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the Mortgagors promise to pay to the Mortgagee the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage insurance premium and on their failure to pay it, the mortgagee may advance it for the Mortgagors' account and collect it as a part of the debt secured by this mortgage.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
