C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, containing 3/10 of an acre, more or less, adjoining the lot of W. E. Owens on the South, on the West by U. S. Highway No. 29, on the East by the P & N Railroad, and on the north by Ore Mae Hollingsworth, and having the following metes and bounds:

BEGINNING at a point in the center of U. S. Highway No. 29 and running thence N. 86 E. 3.50 chains to the center of the P & N Railroad; thence along the center of the P & N Railroad, N. $5\frac{1}{2}$ E. 1.00 chains to a point; thence S. 86 W. 3.64 chains to the center of U. S. Highway No. 29; thence along the center of said highway, S. 7 E. 1.00 chains to the beginning corner.
