WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Seven Thousand Eight Hundred and no/100 ----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain lot of land lying in the State of South Carolina, County of Greenville, Gantt Township, known and described as Lot No. 9 on a Plat of Gantt Heights recorded in the RMC Office for Greenville County in Plat Book W at Page 143 and being further described according to the said Plat as follows:

BEGINNING at an iron pin on the southern side of Linda Avenue at the joint corner of Lots Nos. 8 and 9 and running thence along the line of Lot No. 8 S 23-00 W 168.1 feet to an iron pin in the line of property now or formerly of Ed Gainer; thence along the line of the Gainer property S 69-12 E 59.95 feet to an iron pin at the corner of Lot No. 10; thence along the line of Lot No. 10 N 23-00 E 169.5 feet to an iron pin on the southern side of Linda Avenue; thence along Linda Avenue N 70-30 W 60 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
