WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Thirty.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgager to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that certain piece, parcel or lot of land situate, lying and being on the Northern side of Edwards Road near the City of Greenville, being a portion of Tract No. 8 per plat of property of L. L. Richbourg, prepared by Dalton & Neves, Engineers, dated October, 1944, and recorded in the R.M.C. Office for Greenville County in Plat Book R at page 65 and being known and designated as Parcel No. 27 as shown on a plat of property of Williamsburg Manor, Inc., prepared by Webb Surveying & Mapping Co. dated December, 1965 as revised December, 1967, and having according to said revised plat the following metes and bounds:

BEGINNING at an iron pin on the easterly side of a private drive at joint front corner of Parcels Nos. 13 and 27 and running thence with the said joint line N. 82-01 E. 100 feet to an iron pin; thence N. 48 E. 90 feet to an iron pin; thence N. 28-30 W. 60 feet to an iron pin at rear corner of Parcel 28; thence along the joint line of Parcels Nos. 27 and 28 N. 38-23 W. 100.6 feet to an iron pin; thence S. 78-40 W. 74.8 feet to an iron pin on the southerly side of said private drive; thence along said drive S. 7-59 E. 87 feet to an iron pin; thence S. 82-01 W. 26 feet to an iron pin on said driveway; thence further along said driveway S. 7-59 E. 100 feet to an iron pin, at the point of beginning.

ALSO: The right to use, for purposes of ingress, egress and parking, all adjacent private drives of the mortgagor.
