All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Lamont Lane near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 7 as shown on a plat of Lee Heights, prepared by Campbell & Clarkson, Surveyor, dated December 6, 1967, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book WWW at page 7, being a revision of Lots Nos. 30, 31, 32, 33 and 34 as shown on a plat of Dixie Farms, prepared by Dalton & Neves, dated December 1939, and recorded in the R.M.C.
