NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Dunklin Township, containing one-half (1/2) acre, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the line of property of Sally E. Sims, joint corner with other lands of J. R. Sims and running thence with the joint line of said Sally E. Sims S. 35 1/2 E. 150 feet to an iron pin at joint right-of-way which leads from Dunklin Bridge Road northeasterly separating lands of the mortgagors and R. L. Sims and which affords a way of ingress and egress to property of C. E. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
