"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the southwest side of Aldridge Drive shown as Lot No. 64 on plat of Section F of Gower Estates, made by R. K. Campbell and Webb Surveying & Mapping Co., November, 1965, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book JJJ, page 99, and having according to said plat, the following metes and bounds, to-wit:
