"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in the City of Greenville, being known and designated as Lot 114 as shown on a plat of Isaqueena Park, recorded in Plat Book P at pages 130 and 131 and according to a more recent survey prepared by J. C. Hill January 28, 1950 is described as follows:
