"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the north-western side of Douglas Drive, being shown as Lot No. 12 on a plat of Martindale Subdivision dated June, 1959, prepared by C. O. Riddle, and recorded in Plat Book BBB at Page 97 in the RMC Office for Greenville County, and having according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the northwestern side of Douglas Drive at the joint front corner of Lots 11 and 12 and running thence with Lot No. 11 N. 59-03 E. 171 feet to an iron pin on a County Road; thence with said road N. 30-58 E. 250.6 feet to an iron pin; thence S. 30-38 E. 104.6 feet to an iron pin at the joint corners of Lots 12 and 13; thence with lot 13 S. 5-19 E. 137 feet to an iron pin on Douglas Drive; thence with the curvature of Douglas Drive the chord being S. 33-27 W. 90.6 feet to the point of beginning.

This is the same property conveyed to the mortgagors by deed of Martha W. Greene to be recorded herewith.

The Mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may, at its option, apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one-half of one per cent of the principal balance then existing.
