ments shall be charged to such fund. The Trustee shall sell and reduce to cash funds a sufficient portion of investments under the provisions of this Section 702 whenever the cash balance in the Bond Fund is insufficient to pay the current interest and principal requirements. The Trustee may make any and all investments permitted by the provisions of Section 701 and this Section 702 through its own Bond Department.
