"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of
All that piece, parcel, or lot of land with all the improvements thereon situate lying and being in
the State of South Carolina, County of Greenville, in Oaklawn Township, the same being a portion of
Tract No. One (1) on Plat of the Estate of Morning Kelly Epps by W. J. Riddle, dated October 1925
and recorded in the R. M. C. office of Greenville County in Plat Book "h" at page 35, same contains
approximately four (4) acres, and has, according to said Plat, the following courses and distances,

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
