NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Rosewood Circle near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 90 as shown on a plat of Peachtree Terrace, Section No. 2, prepared by G. A. Wolfe, dated May 1, 1965, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 105 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Rosewood Circle at the joint front corner of Lots Nos. 89 and 90 and running thence with the line of Lot No. 89 N. 27-52 W. 185.6 feet to an iron pin; thence S. 60-00 W. 80 feet to an iron pin at the joint rear corner of Lots Nos. 90 and 91; thence with the line of Lot No. 91 S. 18-13 E. 162.3 feet to an iron pin on the Northern side of Rosewood Circle; thence with the Northern side of Rosewood Circle N. 77-04 E. 22.1 feet to an iron pin; thence continuing with the Northern side of Rosewood Circle N. 73-57 E. 50 feet to an iron pin; thence still continuing with the Northern side of Rosewood Circle N. 11-16 E. 37.9 feet to the point of beginning.
