WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Twenty One Thousand and no/100----
(\$ 21,000.00), with interest thereon at the rate of Six & three-fourths cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northwestern

corner of Verner Drive and Stradley Terrace, near the City of Greenville, being shown as Lot 44 on a plat of Cedar Vale, recorded in Plat Book 000 at page 13 and described as follows:

BEGINNING at an iron pin at the northwestern corner of Verner Drive and Stædley Terrace, and running thence with the northern side of Verner Drive, N. 72-01 W. 65.8 feet and North 74-42 W. 78 feet toan iron pin at the corner of Lot 43; thence with line of said lot, N. 19-13 E. 107.3 feet to iron pin at corner of Lot 45; thence with the line of said lot, S. 70-47 E. 168.5 feet to iron pin on Stradley Terrace; thence with the western side of said Terrace, S. 19-13 W. 75 feet to iron pin, corner of Verner Drive; thence with the curve of the intersection S. 67-31 W. 35.7 feetto the Beginning corner.
