"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Standing Springs Road, and having, according to plat entitled Property of Sandra K. Gooch and Jerry L. Gooch, prepared by T. H. Walker, Jr., dated March 30, 1968, the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of Standing Springs Road and running thence with the center line of said road, S. 16-29 W., 146 feet to a nail and cap; thence with the line of David F. & Julia Ann Campbell, N. 71-38 W., 349.5 feet to an iron pin, passing over iron pin on edge of road; thence with the line of J.
