NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the Northeast side of Memorial Drive Extension, about two miles northwest of the City of Greer, and being known and designated as portions of Lots Nos. Six (6) and Seven (7) of the W. Dennis Smith property as shown on plat prepared by H. S. Brockman, Surveyor, dated April 5, 1955 and which plat has been recorded in the R. M. C. Office for said County in Plat Book FF, page 294, and having according to said plat and a survey dated Dec. 5, 1960 by R. W. Dalton, Engineer, the following metes and bounds, to-wit: Beginning at an Iron Pin on the Northeast side of Memorial Drive Extension, in the front line of lot no. 6, said pin being located 114 feet in a Westernly direction from the Northwest corner of the intersection of Memorial Drive Extension and Smith Drive, and running thence through lot no. 6, N.31-08 E.170 and Smith Drive, and running thence through lot no. 6, N.31-08 E.170 feet to an Iron Pin at the joint rear corner of lots nos. 5 and 6, thence N.41-40 W.100 feet to an Iron Pin at the joint rear corner of lots nos. 6 and 7, thence through lot no. 7, S.31-03 W.168.4 feet to an Iron Pin on the Northeast side of Memorial Drive Extension, thence along Memorial Drive Extension S.35-45 M.14 feet to an Iron Pin at joint front corner of lots nos. 6 and 7, thence along Memorial Drive Extension S.41-41 E.86 feet to the beginning point.
