REAL ESTATE MORTGAGE

THE STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE

WHEREAS, JERRY L. DILL AND HIS WIFE, BARBARA R. DILL, here-inafter called Mortgagor, is indebted to PHILLIPS PETROLEUM COMPANY, a Delaware corporation having an office at Raleigh, North Carolina, hereinafter called Mortgagee, in the principal amount of Six Thousand Four Hundred Forty Seven and 65/100 Dollars (\$6,447.65), with interest thereon at the rate of seven percent (7%) per annum on the declining balance as evidenced by a certain promissory note of even date herewith, said indebtedness being payable in installments as follows:
