"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 4 of a subdivision of the property of Alvin B. Hood, Block A, according to a plat thereof prepared by C. O. Riddle, dated October 20, 1967, and recorded in the R. M. C. Office for Greenville County in Plat Book WWW, at Page 2, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the eastern side of Cunningham Road, at the joint front corner of Lots Nos. 4 and 5, and running thence with the joint line of said lots, N. 85-59 E. 191.6 feet to an iron pin at the joint rear corner of Lots Nos. 4 and 5; thence with the rear line of Lot No. 4, S. 11-06 E. 96 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence with the joint line of said lots, S. 80-20 W. 198.5 feet to an iron pin on the eastern side of Cunningham Road, joint front corner of Lots Nos. 3 and 4; running thence with the eastern side of Cunningham Road, N. 7-00 W. 115 feet to the point of Beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
