It is hereby agreed that should any default be made in the payment of interest on siad first martgage, and such interest remains unpaid and in arrears for the days, or should any suite be commenced to foreclose said first mortgage, then the amount secured by this mortgage and the accompanying mote shall become and be due and payable at any time thereafter at the option of the owner or holder of this mortgage.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor his heirs, executors, or administrators, shall keep the buildings crected, or to be erected on said premises, insured against loss or damage by fire, for the benefit of the said mortgagee, for an amount not less than (21.60.00)

Dollars, in such company as shall be approved by the said mortgagee, and shall deliver the policy to the said mortgagee, and in default thereof,
