## **MORTGAGE**

Mac Richardson, Surveyor, dated October, 1958, and recorded in the RMC Office for Greenville County, S. C., in Plat Book QQ, page 108, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Western side of Kenmore Drive at the joint front corners of Lots Nos. 96 and 97, and running thence along the Western side of Kenmore Drive, S. 0-50 W., 112.68 feet to a point in the center line of Lot No. 98; thence a new line through the center of Lot No. 98, S. 88-02 W., approximately 288.6 feet to an iron pin in the center of the rear line of Lot No. 98; thence N. 0-50 E., 112.5 feet to an iron pin at the joint rear corners of Lots Nos. 96 and 97; thence along the common line of said lots, N. 88-02 E., 294.1 feet to an iron pin, the beginning corner.
