- (3) That he will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction loan, that he will continue construction until completion without interruption, and should be fail to do so, the Mortgagee may, at Mortgagee's option, declare the whole amount of said note immediately due and payable and foreclose this mortgage, or mortgage may enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
- (4) That he will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against mortgaged premises, and will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.
