NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and in the Town of Simpsonville, on the West side of Hedge Street, running along said Hedge Street, the western side, 190 feet in a northerly direction; thence in a westerly direction 125 feet to corner of another lot of the mortgagor; thence with the joint line of other lot of the mortgagor in a southerly direction 190 feet to corner with other lot of the mortgagor on Richardson Street; thence with said Richardson Street in an easterly direction 125 feet to corner at intersection of said Street with the said Redge Street, and bounded by other property of the mortgagor, property of the mortgage and said Hedge and Richardson Streets.
