That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville on the southwestern corner of the intersection of Chateau Drive and Glenwaye Drive and known and designated as Lot No. 120 of a subdivision known as Merrifield Park, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book OOO at Page 177 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Chateau Drive at the joint front corner of Lots Nos. 119 and 120 and running thence with the joint line of said lots S. 88-20 W., 175 feet to an iron pin; running thence N. 1-40 E., 134 feet to an iron pin on the southern side of Glenwaye Drive; running thence with the southern side of said drive S. 83-25 E., 46.9 feet to an iron pin; thence continuing with said drive S. 88-20 E., 103.4 feet to an iron pin at the intersection of Glenwaye Drive with Chateau Drive, which intersection is curved the chord of which is S. 43-20 E., 35.4 feet to an iron pin on the western side of Chateau Drive; running thence with the western side of said drive S. 1-40 W., 105 feet to an iron pin, point of beginning.
