As further security for payment of the indebtedness and performance of the obligations, covenants and agreements secured hereby, Morigagor does hereby transfer, set over and assign to Morigagoe.

(a) All rents, issues and profits of the premises from time to time accruing, whether under leases or tenancies now existing or hereafter oreated reserving to Morigagor, however, so long as Morigagor is not in default hereunder, the right to receive and stain such rents, issues and profits.

(b) All judgments, awards of damages and settlements hereafter made resulting from condemnation proceedings, or in lieu of any taking of the premises or any part thereof under the power of eminent domain, or for any damage, (whether

- - All judgments, swards or damages and severeness necester made resulting from condemnation proceedings, or in lieu of any taking of the premises or any part thereof under the power of eminent domain, or for any damage, (whether caused by such taking or otherwise) to the premises or the improvements thereof or any part thereof, or to any rights appurtations after the collection of the premises of grade of streets. Mortgages is hereby authorized, but not required on helial and in the name of Mortgager, to execute and deliver valid acquittances for, and to appeal from, any such judgments or awards.
