"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, just off East North

Street, near the City of Greenville, being shown and designated as Lot No. 16 on Plat entitled "Property of Walter E. Rumminger, Gene Fisher and Harold J. Seeley", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4A, , at Page , and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of a 24 foot asphalt driveway which extends South from East North Street, said point being at the joint front corner of Lots Nos. 14 and 16 and running thence with the line of Lot No. 14 N. 66-49 E. 95.2 feet to a point; thence S. 30-58 E. 58 feet to a point at the corner of Lot No. 18; thence with the line of Lot No. 18 S. 63-24 W. 92.2 feet to a point on the eastern side of said asphalt driveway; thence along said driveway in a northerly direction 64.3 feet, more or less, to the point of beginning.
