"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, county of Greenville, All that lot of land situate on the Southwest side of Devenger Road, near the city of Greenville, in Greenville County, S.C. with the buildings and improvements thereon having according to a survey made by Madison H. Woodward, engineer June 10, 1963, and being a portion of that property shown on plat recorded in the R.M.C. Office for Greenville County, S.C. in plat Book "H" page 241, the following metes and bounds to-wit:

BEGINNING, at an iron pin in the center of Devenger Road at the Northwest corner of lot of T.P.
