"ALL that certain piece, parcel or let of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot Number One Hundred Thirty Eight (No.138) on a plat of subdivision of property of Charlotte A. Tripp, Brutontown, made by Fitzpatrick-Terry Company, Engineers, June 1920, recorded in the RaM. C. office for Greenville County in Plat Book "E", page 254, and, according to said plat, having the following metes and bounds, to vit:

REGINNING at an iron pin on the southern side of Boling Circle, joint corner of Lots Nos. 137 and 138, and running thence with the line of Lot No. 137, 1h5.5 feet to an iron pin; thence in a westerly direction, Twenty Five (25) feet to an iron pin, joint corner of Lots Nos. 138 and 139; thence with the line of Lot No. 139, 1h3.2 feet to an iron pin on the southern side of Boling Circle; thence with the southern side of Boling Circle, Twenty Five (25) feet to an iron pin, the beginning corner.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
