All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying at the northwestern corner of the intersection of Confederate Circle and Brookridge Drive and known and designated as Lot No. 23 of a subdivision known as Sheffield Forest, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book AAA at Page 47 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Jeb Stuart Avenue, joint front corner of Lots Nos. 23 and 24; thence with the joint line of said lots, N. 6-0 W. 150 feet to an iron pin in the line of Lot No. 21; thence with the lines of Lots Nos. 21 and 22, N. 84-00 E. 127.6 feet to an iron pin on the western side of Brookridge Drive. joint corner of Lots Nos. 22 and 23; running thence with the western side of Brookridge Drive, S. 1-22 E. 125.5 feet to an iron pin at the intersection of Brookridge Drive and Jeb Stuart Avenue; thence with the curvature of said intersection, the chord of which is S. 48-41 W. 33.8 feet to an iron pin on the northern side of Jeb Stuart Avenue; thence with the northern side of Jeb Stuart Avenue, S. 84-0 W. 90.3 feet to the point of beginning; being the same conveyed to me by J. H. Mauldin by deed of even date, to be recorded herewith.

The street referred to above as Confederate Circle is also known as Jeb Stuart Avenue.
