"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, altuate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot Number 42, Section 2, Pelham Estates, as shown on a plat thereof prepared by Pledmont Engineers and Architects dated May 12, 1967, of record in the Office of the RMC for Greenville County in Plat Book "PPP", Page 119, reference to which is craved for a more definite metes and bounds description thereof.

This mortgage is second and junior in lien to that certain mortgage of John C. Cothran and Ellis L. Darby, Jr. to First Federal Savings & Loan Association in the original amount of \$29,500.00 of record in the Office of the RMC for Greenville County in R. E.M. Book 1079, Page 94, this date assumed by the mortgagor.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the partles hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
