MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Jack E, Shaw Builders, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of Two Hundred Thirty Nine and 27/100-{ \$239.27} Dollars each on the first day of each menth hereofter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not somer paid, to be due and payable years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thercunder shall be past due and unpaid for a period of thirty days, or if their shall be any failure to comply with and abide by any By-Laws or the Clarter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thercunder shall at the option of the helder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said ande and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and
