- (4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.
- (5) That it horeby assigns all rents, issues and profits of the mortgaged premises from and after any default herounder, and agrees that, should legal proceedings be instituted pursuant to this instrument, any judge having jurisdiction may, at Clambers or otherwise, appoint a receiver of the mortgaged premises, with full authority to take possession of the mortgaged premises and collect the rents, issues and profits, including a reasonable rental to be fixed by the Court in the overt said premises are occupied by the mortgagor and after deciding all changes and expenses attending such preceding and the execution of its trust as receiver, shall apply the residue of the rents, issues and profits toward the payment of the debt secured hereby.

- (7) That the Mortgagor shall hold and enjoy the premises above convoyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and of the note secured hereby, that there this mortgage shall not unterly null and void; otherwise to remain in full force and virtue.
- (8) That the covenants herein contained shall blud, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors and assigns, of the parties hereto. Whenever used the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
