NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at any before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate, lying and being on the north and west sides of Clark Avenue near the town of Greer, and known and designated as Lot No. 46 of a subdivision known as Brookhaven, plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book RR at page 41, and according to said plat, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Clark Avenue, corner of Lots Nos. 46 and 47, and running thence along the line of said lots, N. II-02 E. 170 feet to the rear corner of Lot No. 45; thence along the line of Lot No. 45, S. 79-25 E. 137.3 feet to an iron pin on the west side of Clark Avenue; thence along said avenue, S. 35-30 W. 160.6 feet to a curve in said avenue; thence along said avenue in a curving line, the chord of which is S. 68-03 W. 45.2 feet to an iron pin; thence continuing along said avenue, N. 79-25 W. 31.6 feet to the beginning corner.
