NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Devonshire Lane near the City of Greenville, being shown as Lot No. 33 on Plat of Section I of Northwood Hills, recorded in Plat Book RR at page 15 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the northern side of Devonshire Lane. 130 feet east from Kingsbury Road, at the corner of Lot 34, and running thence with the northern side of said Lane, N 73-00 E 135 feet to an iron pin at corner of Lot 32; thence with line of said lot, N 17-24 W 177,2 feet to an iron pin at corner of Lot 38; thence with the line of said lot, N 81-30 W 46.6 feet to an iron pin at corner of Lot 35; thence with line of said lot, S 34-44 W 108.5 feet to an iron pin at corner of Lot 34; thence with the line of said lot, S 14-00 E 130 feet to the beginning corner.
