t t	nid mortgage being recorded in the RMC Office for Greenville County in Book. 28.3 at Page. 3/6, title which mortgaged premises is now vested in the said Obligor, and the said Obligor has requested the Association o readvance to him sums paid on the said note and mortgage and to extend the time for the performance of the bligation,
١	OW THEREFORE:
t	1. In consideration of the readvance to the Obligor of the sum of \$\frac{49 \text{Fo.}^{27}}{27}\$ and the extension of the time for performance, the Obligor agrees that the rate of interest on the entire amount now due, including the readvance, be increased to \frac{3}{27} per cent, per annum, and the Obligor does hereby agree that the said redvance was advanced by the Association for the account of the Obligor and that the said sum shall be secured by the said note and mortgage.
t	2. It is mutually agreed that the principal indebtedness, including the readvance, is \$ 5.926.01, and hat it shall be paid in monthly installments of \$ 20.00 cach on the 20.00 day of each month hereafter, aid payments to be applied first to interest, and then to principal until paid in full.
i I	3. Obligor agrees that if a default shall exist for a period of thirty (30) days in the failure to pay the rincipal indebtedness of any installment thereof or interest thereon or in the performance of any of the terms and onditions of the obligation as modified by this agreement, the Association may, at its option, declare the entire rincipal indebtedness with interest immediately due and payable and may proceed to collect same and avail tself of all rights and remedies given to it under the obligation in the event of a default.
	 All terms and conditions of the obligation shall continue in full force except as modified expressly by his agreement and the statute of limitations will not commence to run against the obligation until the expiration of he time for payment of the indebtedness as herein extended.
	5. This agreement shall bind jointly and severally the heirs, the executors, the administrators, the successors and the assigns of the Association and of the Obligor respectively.
