AND IT IS COVENANTED AND AGREED by and between the parties hereto that all gas and electric fixtures, radiators, heaters, engines and machinery, boilers, ranges, elevators, and motors, bath-time, stacks, water-closets, basins, pipes, faucets and other plumbing and heating fixtures, mirrors, mantels, refrigerating pant and ice-boxes, cooking apparatus and appurtenances, and such other goods and chattels and personal property as are furnished by a landlord in letting or operating an unfurnished building, similar to the one herein described and referred to, which are or shall be attached to said building by nails, screws, boits, pipe connections, masons, or in any other manner, are and shall be deemed to be fixtures and an accession to the freshold and a part of the analysa between the parties hereto, their heirs, executors, administrators, successors and assigns, and all persons, aiming by, through or under their, and shall be deemed to be a portion of the security for the indebtedness herein mentioned and to be covered by this mortgage.
