NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any Intrins units which may be advanced by the Mortgager to the Mortgagor's account, and also in consideration of the sum of Three Dallas (\$3.00) to the Mortgager in hard well and truly paid by the Mortgage and before the scaling of these presents the receipt whereof is bereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, self and reclasse unto the Mortgager, its successors and assigns, the following described restate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Del Norte Road, being shown as Lot No. 147 on plat entitled "Del Norte Estates" recorded in the R. M. C. Office for Greenville County in Plat Book WWW, at pages 32 and 33, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Del Norte Road at the joint front corner of Lots Nos. 146 and 147, and running thence N. 44-05 W. 140 feet to an iron pin in the line of Lot No. 154; and running thence with the rear lines of Lots 154 and 153, N. 45-55 E. 100 feet to an iron pin at the joint rear corner of Lots 147 and 148; thence with the joint line of said lots, S. 44-05 E. 140 feet to an iron pin on the northwestern side of Del Norte Road, joint front corner of Lots 147 and 148; thence with the northwestern side of Del Norte Road, S. 45-55 W. 100 feet to the point of beginning; being the same conveyed to the mortgagor corporation by Threatt-Maxwell Enterprises, Inc. by deed dated August 7, 1969, to be recorded herewith.
