MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, WE, JAMES E. EDWARDS AND ALTHEA M. EDWARDS.

(hereinafter referred to as Mortgagor) is well and truly indebted unto . EDWARDS AND EDWARDS.

(hereinalter referred to as Mortgages) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Two Thousand Nine Hundred Dollars ----- Dollars (\$ 2,900,00--) due and payable

at the rate of Fifty Eight and 81/100 Dollars (\$58.81) per month, beginning September 22, 1969 and each month thereafter for Sixty (60) months,

with interest thereon from date at the rate of 35 per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for texes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgager, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgager may be indebted to the Mortgager at any time for advances made to or for his account by the Mortgager, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgager in hand well and truly paid by the Mortgager at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgager, lis successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Heal Township, about one-half aile west from O'Heal, lying on the southeast side of the road that leads from the May's Bridge Road to the Oneal School and on the northern side of a community road, being bounded on the northwest by the above named road and lends of M. E. Duncan, on the east by lands of Amnie 3. Roe and on the Southwest by lands of H. M. Fitts, and being the same lot of land conveyed to me by deed from Amnie B. Roe, October 29, 1953, recorded in the office of 4.1.0. for Greenville County in Deed Book 188 page 6 and having the following courses:

BEGINNING on an iron pin in the center of the above nessed road; joint corner of lends of L. 2. Januar and of H. M. Fitts and I. E. Dancan and on the original line of lunds of Aunie B. Roe, and runs thence with the Annie B. does original line S. 0-15 E. 234 feet to an iron pin on the said original Roe line and being in the said community road; thence with this community road N. 62-10 M. 168 feet to an iron pin in the road that lends to the Oncal January; thence with this road N. 43-15 E. 215 feet to the beginning corner, containing Four Fenths (0.4) of one acre more or less.

This is the same piece of property conveyed to us by Granton's name 2. doe October 17, 1953 and recorded in the Greenville County 3.E.C. Office October 23, 1995 and recorded in Book 488 Page 6.

Together with all and singular rights, members, herditaments, and appurtamences to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all healing, plumbing, and lighting instructs now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgages, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all lions and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever detend all and singular the said premises unto the Mortgagor from and against the Mortgagor and all persons whomsoever fawfully claiming the same or any part thereof,
