All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Saluda Township, about 19 miles from Greenville County Courthouse, and about one mile from New Liberty Church, adjoining lands of June Anderson, Will cox, Estate of Willie Earle Poole, et al., and having the following metes and bounds, to-wit:

BEGINNING at an iron pin 3xnm on the eastern side of the Old Pickens Road (S.C. Hwy 414) at the corner of land heretofore conveyed by W.C.
