National Bank of South Carolina, its successors and assigns forever. Anddo hereby bir
lieirs, executors, administrators and assigns, to warrant and forevide fend all and singular the said premises unto the said. The Citizens & Southern National Bank of Souther
Carolina, its successors and assigns from and against heirs, executors, administrators and assigns and all others whomsoever lawfully claiming or to claim the same or any part theree
and heirs, executors, administrators and assigns covenant with the mor gagee, its successors and assigns that at and until the ensealing of these presents I was well seized of the above described premises as a good and indefensible estate in fee simple and have good right to sell and examiner and convey the same, and that the same are free from all encumbrances and liens whatsoever.
AND IT IS AGREED BY AND BETWEEN THE SAID PARTIES:

- The mortgagor will pay said Note or obligation as herein and in said Note or obligation provided and agrees that all overdue interest and past due principal shall draw interest at the rate of seven (7%) per cent, per annum.
- 2. Before they become delinquent, the mortgagor will pay all taxes, assessments and charges of every character which are now due or which may hereafter become hens on said premises, including all taxes assessed in the State in which the mortgaged premises are situated against the mortgagee or its assigns on this instrument or the sum hereby secured does not exceed the maximum permitted by what if it does, the excess is to be paid by the mortgagee, and will immediately deliver to the mortgagee, its successors or assigns, at its office, receipts of the proper officers therefor, and if not paid the mortgagee may pay such taxes, assessments and charges (of which payment, amount and validity thereof the receipt of the proper officer shall be conclusive evidence) and any amount so paid shall be the and payable immediately or on demand at the option of the mortgagee with interest at Six (\$\text{\$\empirece{g}\$}_c\$) per cent, per amoun and shall be secured by this instrument.
- 3. The mortgagor will keep the buildings on said premises insured against loss by fire and tornado in companies and amounts satisfactory to and with loss made payable to the mortgagee and deliver the policies marked "Paid" to the mortgagee and renewals thereof at least seven days before the expiration of the old policies. In default thereof, the mortgagee may effect such insurance and the amount so paid shall be due and payable immediately or on demand at the option of the mortgagee, with interest at Six (6%) per cent, per minima and shall be secured by this instrument. In the event of the passage after the date of this instrument of any law of the State in which the mortgaged premises are situated deducting from the value of the land for the purposes of taxation any lien theory, or providing or changing in any way the laws now in force for the taxation of mortgages or debts secured thereby, for state or local purposes or the manner of the collection of any such taxes so as to affect the interest of the mortgagee, the whole sam secured by this instrument with interest thereon, at the option of the mortgagee shall immediately become due, payable and collectible without notice.

In the event of default in the payment of the indebtedness hereby secured or any part thereof or in any of the covenants or conditions of this mortgage, at the option of the mortgagee, without notice, notice of the exercise of such option hereby expressly waived, the entire indebtedness secured by this instrument shall immediately become due, payable and collectible and the mortgage shall have power to sell said premise according to law and this mortgage may be foreclosed and the mortgagee shall be entitled to the immediate appointment of a receiver without notice for the collection of the rents of said premises during the pendency of such foreclosure and the rents and profits of the premises are hereby assigned to the mortgagee as security for the payment of such indebtedness.
