- a. The lies of this instrument shall remain in full love and effect during any postponement or extension of the time of payment of the indebtedness or any part thereof secured hereby.
- 8. He will pay all taxes, assessments, water rates, and other governmental or municipal charges, fines, or impeditions for which provided has not been made hereinbefore, and in default thereof the Mortgages may pay the same; and will promptly deliver the official receipts therefor to the Mortgages. If the Mortgager fails to make any payments provided for in this section or any other payments for taxes, assessments, or the like, the Mortgages may pay the same, and all sums so paid shall bear interest at the rate provided for in the principal indebtedness from the date of such advance and shall be secured by this mortgage.
- 6. Upon the request of the Mortgagee the Mortgager shall execute and deliver a supplemental note or notes for the sum or sums advanced by the Mortgagee for the alteration, modernization, improvement, maintenance or repair of said premises, for taxes or assessments against the same and for any other purpose authorized hereunder. Said note or notes shall be secured hereby on a parity with and as fully as if the advance evidenced thereby were included in the note first described above. Said supplemental inde or notes shall bent interpret at the rate provided for in the principal indebtedness and shall be payable in approximately equal monthly payments for such period as may be agreed upon by the creditor and debtor. Failing to agree on the insturity, the whole of the sum or sums so advanced shall be due and payable thirty (30) days after demand by the creditor.
