(3) That it will keep all improvements now existing of ferentier greated in good report, and, in the case of a construction loan, that it will confinue construction until completion without interruption, and should it fall to do so, the Marigages may, at its option, enter upon sold premises, make whatever reports are increasingly, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of a vach construction to the marigage dabt.

- (4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.
