TOGETHER with all and singular the Rights, Members Hereditaries and Appurtenances to the said Premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular forever. And they do hereby bind their Heirs, said Premises unto the said mortgagee, its successors and every person whomsoever lawfully



as mortgagee, its successors and Assigns forever defend all and singular the Heirs, Executors, Administrators and Assigns of the said mortgagee.

The mortgagor does hereby covenant and warrant against all loss or damage by fire, in now or hereafter existing upon said real estate, default thereof said mortgagee may procure and pay the debt as a part of the principal and the same shall mortgage debt and the lien of the mortgage shall be to procure and maintain (either or both) said insurance mortgagee, become immediately due and payable, and or maintained such insurance as above permitted.

the amount sufficient to cover this mortgage herein, upon all buildings to the mortgagee as additional security, and in the event of the expense thereof to the face of the mortgagee and in the same manner as the balance of the mortgage shall fail to be secured hereby shall, at the option of the mortgagee, whether or not said mortgagee shall have procured

Mortgagor does hereby covenant and agree to pay when due all taxes and assessments that may be levied or assessed against said real estate, and also all judgments or other charges, liens or encumbrances that may be recovered against the same or that may become a lien thereon, and in default thereof said mortgagee shall have the same rights and options as above provided in case of insurance.

And if at any time any part of said debt, or interest thereon, be past due and unpaid, Mortgagors hereby assigns the rents and profits of the above described premises to the said mortgagee, or its successors or Assigns and agree that any Judge of the Circuit Court of said State, may, at chambers or otherwise, appoint a receiver, with authority to take possession of said premises and collect said rents and profits, applying the net proceeds thereof (after paying costs of collection) upon said debt, interest, cost of expense; without liability to account for anything more than the rents and profits actually collected.

AND IT IS AGREED, by and between the said parties in case of default in any of the payments of interest or principal as herein provided for, the whole amount of the debt secured by this mortgage shall become due and payable at once at the option of the mortgagee.

AND IT IS AGREED by and between the parties that in the case of foreclosure of this mortgage, by suit or otherwise, the mortgagee shall recover of the mortgagor a reasonable sum as attorney's fee, which shall be secured by this mortgage, and shall be included in judgment of foreclosure.

PROVIDED ALWAYS, nevertheless, and it is the true intent and meaning of the parties of these Presents, that when the said mortgagor, do and shall well and truly pay or cause to be paid unto the said mortgagee the debt or sum of money aforesaid, with interest thereon, if any be due, according to the true intent and meaning of said note, then this deed of bargain and sale shall cease, determine, and be utterly null and void, otherwise to remain in full force and virtue.
