"ALL that certain piece, parcel or let of land, with all improvements thereon, or herselfter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, at the corner of Sunflower Drive and Cemetery Street in the City of Greenville, being known and designated as Lot No. 6 on plat of lands of Estate of Gabriel Moore, which was made by W. D. Neves, Engineer, in August, 1920, and recorded in the R. M. C. Office for Greenville County in Plat Book F at page 82 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin intersection of Cemetery Street and thence with Cemetery Street N. 48-45 E. 60 Feet to a new corner; thence N. 45-15 W. 45 feet to a new corner; thence S. 48-15 W. 86 feet to an new corner on Sunflower Drive; thence with Sunflower Drive S. 73 E. 50 feet to the beginning corner.

ALSO:

ALL that certain piece, parcel or lot of land adjoining the above described lot of land, being known and designated as Lot No. 5 on said plat and having the following metes and bounds, to-wit:

BEGINNING at an iron pin corner on north side of Sunflower Drive, the same being the common corner of Lots 5 and 6; and running thence with line of Lot No. 6 N 48-45 E. 86 feet to an iron pin on line of Lot No. 7; thence with line of Lot No. 7 N. 41-15 W. 39 feet to an iron pin on line of Lot No. 4; thence S. 45-10 W. 107. 5feet to an iron pin on the north side of Sunflower Drive; thence with line of said Drive S. 73 E. 40 feet to the beginning corner.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
