

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, William C. Reaves and Barbara F. Reaves

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor and also in consideration of the sum of sents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by the presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, within the corporate limits of the City of Mauldin, and being known and designated as Lot No. 118 of a subdivision known as Glendale, a plat of same being recorded in the R. M. C. Office for Greenville County in Plat Book "QQ" at pages 78 and 77, and said lot having the following metes and bounds:

BEGINNING at a point on the northern side of Drury Lane at the joint front corner of Lots Nos. 117 and 118 and running thence N. 11-16 E. 170.9 feet to a point at the joint rear corner of Lots Nos. 117 and 118; thence S. 78-44 E. 145 feet to a point on the western side of Rowan Street at the joint corner of Lots Nos. 109 and 118; thence with the western side of Rowan Street, S. 11-16 W. 145.9 feet to a point; thence following the curvature of the northwestern intersection of Rowan Street with Drury Lane (the chord of which is S. 56-16 W. 35.3 feet) to a point; thence with the northern side of Drury Lane, N. 78-44 W. 120 feet to the point of beginning, being the same property conveyed to us by deed of C. Mac Smith and Virginia G. Smith by deed to be recorded herewith.
