C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgager.a. in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Gregans Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, containing 3.5 acres, more or less, situated near Ridge Road and northward therefrom, about 2 miles southward from Pleasant Hill Church, bounded by lands of Harper D, Hawkins and D. W. Arms, and having courses and distances according to a survey and plat by W. N. Willis, Engineers, dated April 12, 1968, for W. D. Arms, as follows, to with (Plat Book SSS, page 116)

ECOINNING at an iron pin on the west side of an unimproved road leading from Hidge Road to the residence of W. D. Arms and on the south side of a driveway, and running thence along said driveway, N. 88 W. 100 feet; thence S. 3-30 W. 112 feet to an old iron pin on the Hawkins line; thence along the Hawkins line, N. 89-26 W. 389 feet to an old iron pin; thence continuing along the Hawkins line, N. 5-20 E. 111 feet to an iron pin on D. W. Arms line; thence along the Arms line, N. 81-07 E. 329 feet to an iron pin; thence continuing along the Arms line, N. 293 feet, more or less, to the north side of a driveway, S. 88 E. 100 feet, more or less, to the west side of the unimproved road; thence along said road 30 feet to the beginning corner.

There is included in the above described boundary the driveway 30 feet wide extending from the unimproved road to the lot above, and there is also granted the full right and priviledge to use the unimproved road to and from Ridge Road to the driveway conveyed above.
