"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Hudson Acres Subdivision, a plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book "Y", at page 39, which lot is the major portion of Lot No. 49 as shown on said plat, and which lot is shown and described more particularly according to a more recent plat of the property of Rogelio F. Guerrero and Janet D. Guerrero recorded in the R.M.C. Office for Greenville County in Plat Book "NNN", at page 1, as follows:
